2017 DAC SEPTIC REHABILITATION AND DEMAND REDUCTION PROGRAM

CVWD is accepting applications from Disadvantaged Community Septic System owners for rebates of up to \$30,000 per septic system for completing one of the following types of projects:

- 1. Rehabilitation of existing septic systems to extend their useful life.
- 2. Reducing demand on existing septic system by diverting laundry demand to greywater systems consistent with the "laundry to landscape" requirements in Chapter 16A of the California Plumbing Code for greywater systems that do not require permits or inspection, and utilize the laundry pump for distribution of greywater.

Up to \$250,000 in rebates will be awarded to qualifying applicants. Applications are judged based on application completeness, project feasibility, estimated water savings, groundwater quality protection benefits, and amount requested. An example of a project that would receive a high ranking is one that has a lower cost relative to the number of residents benefitted. Site visits may be conducted during ranking. No more than two rebates will be awarded per applicant, and work proposed in the first rebate application must be completed before the second rebate is awarded.

REQUIREMENTS

- Applicant must be property owner.
- Applicant must not have reasonable access to public sewer infrastructure.
- Applicant must grant CVWD access property for pre and post project inspection of septic system and surface conditions.
- Applicant must document pre project conditions and provide scope of work, estimated cost of work to be completed, and estimated completion date. Contractor cost estimate is preferred.
- Applicant must provide invoices and or receipts to support all reimbursable costs.
- Applicant must be located within a Disadvantaged Community as mapped by the Department of Water Resources Mapping Tool, https://gis.water.ca.gov/app/dacs/
- Greywater systems installed via this rebate program must be "laundry to landscape" and must meet requirements of Chapter 16A of the California Plumbing.
- Applicant is responsible for any additional permitting from the County of Riverside.
- Applicant must attend a one-day septic system best management practices training program which will be provided in cooperation with Pueblo Unido Community Development Corporation.
